Welcome to the third edition of the new SACT newsletter.

We aim to release the newsletter at regular intervals in order to keep SACT colleagues up to date with any developments or new communications.

SACT dataset v3.0

As you will now be aware, the SACT dataset completed a full review in 2018. The new revised SACT dataset v3.0 will be implemented from **September 2019.** The following rules apply:

- SACT v3.0 data collection must commence between September and November 2019.
- The SACT portal will allow data uploads of both SACT v2.0 and SACT v3.0 between September 2019 and January 2020
- From February 2020, v2.0 uploads will no longer be accepted through the portal

We are working with all relevant e-prescribing systems suppliers and have been in contact with in-house suppliers where possible. If you feel your in-house teams have not been contacted, please let the helpdesk know.

We have now started initial testing of the revised dataset. System suppliers may be in touch to invite trusts to take part in the pilots.

SACT outcomes upload

Background

SACT regimen outcomes are vital to evaluate treatment effectiveness but are often missing from the dataset.

This is partly because submission of SACT data occurs shortly after treatment activity. If outcomes are input into trusts systems at any later date, they are never received in the national dataset.

The SACT team have successfully piloted an outcomes upload. The upload contains a subset of 6 SACT data items and will capture outcomes completed on trust systems at any time. In the pilot we saw a significant increase in the number of outcomes we received.

Implementation

- September 2019 Launch of SACT outcomes upload alongside SACT v3.0
- November 2019 Initial upload of SACT outcomes files for outcomes completed in September 2019
- **12 month phased implementation period** Trusts are requested to start submitting the outcomes upload at any time over the 12 months
- December 2020 Full compliance required, all trusts must submit an outcomes upload on a monthly basis

Technical support

The SACT team have been working with e-prescribing system suppliers to develop the additional SACT outcomes upload.

PLEASE NOTE no additional data items are required outside of the standard data collected in SACTv3.0.


We don't currently have a data liaison officer based in the North, however Nicola or Prisclica would be happy to help or arrange a visit.

The Cancer Drugs Fund (CDF)



CDF data collection for osimertinib (NSCLC) and pembrolizumab (urothelial) has now closed. With your help, we have managed to capture 100% patients who received the drugs in the SACT dataset. These patients have been included in reports to the NICE committee to inform treatment re-appraisal. We really do appreciate all the hard work that goes into submitting and reviewing data for these patients, so a **big** thank you from us!

Haematology update

The SACT team recently held a haematology workshop with a group of clinical experts. We are aware that in some cases, the reports we produce and the data we collect is aimed towards solid tumours rather that haematology. Workshop discussions identified SACT outputs which would be useful for the haematology community and work has already started to produce relevant reports. Escalation process

The SACT team have received several questions from trust providers querying the implications of failing to submit SACT data.

Monthly submission of the SACT dataset is required in the NHS England Standard Contract (2019/20). To clarify these requirements and the implications of non-compliance the SACT team have developed a formal "Escalation process". This process will be circulated to all trusts in the coming months and will be shared on our website.

treatment activity reporting suite. This suite is made up of three separate reports; regimen , drug and outcomes level reports. All reports are interactive so the user is able to select specific dates, tumour groups, regimens, and trust/area team. These reports also include GMC level data.
